

## Jasminepetcare Waiver

This waiver (this "Waiver") is made effective as of June 01, 2023, by and between the Client and Jasminepetcare. In this Contract, the party who is contracting to receive the services shall be referred to as "The Client", and the party who will be providing the services shall be referred to as "Jasminepetcare".

Whereas the client wishes to engage with Jasminepetcare and Jasminepetcare agrees to undertake the services under the terms and provisions defined in this Waiver as well as the client's Information sheet Exhibit A and the Veterinary Release Form (Exhibit C) which shall all become part of this Waiver.

**DESCRIPTION OF SERVICES-** Jasminepetcare will provide the following services (collectively, the "Services"):

-Visits to the pet owner's home, usually 20-30 minutes each, to care for pets and the home during the client's absence, overnight stays, dog daycare, in-home boarding or grooming.

**PAYMENT FOR SERVICES.** Jasminepetcare shall be paid the amount of services that we're provided and no deductions shall be made for late departure or early return with less than 48 hours notice. Additional fees may include the purchase of necessary items for the care of the pet, including but not limited to pet food, litter or cleaning supplies, transportation, unexpected visits and emergency expenses for health care. Jasminepetcare shall retain and submit receipts as proof of additional expenses. the client will be in charge of paying for any bills upfront and will receive receipts for their own documents.

**TERM/TERMINATION.** This shall terminate only by the request from the client.

**EMERGENCIES.** In the event of an emergency, Jasminepetcare shall contact the client at the numbers provided to confirm the client's choice of action. If the client cannot be reached in a timely manner, Jasminepetcare is authorized to:

- a. Transport the pet(s) to the listed veterinarian on the attached Veterinary Release Form;
- b. Request on-site treatment from a veterinarian;
- c. Transport the pet(s) to an emergency clinic if the previous two options are not feasible.

**RELATIONSHIP OF PARTIES.** It is understood by the parties that Jasminepetcare is an independent contractor with respect to the client, and not an employee of the client. The client will not provide fringe benefits, including health insurance benefits, paid vacation, or any other employee benefit, for the benefit of Jasminepetcare.

**SECURITY-** the client warrants to keep safe and confidential all keys, remote control entry devices, access codes and personal information of Jasminepetcare and to return same to the client at the end of services or immediately upon demand.

**LIABILITY.** Jasminepetcare accepts no liability for any breach of security or loss of or damage to the clients property if any other person has access to the property during the term of this Waiver. Jasminepetcare shall not be liable for any mishap of whatsoever nature which may befall a pet

or caused by a pet who has unsupervised access to the outdoors. Jasminepetcare is released from all liability related to transporting pet(s) to and from any veterinary clinic or kennel, the medical treatment of the pet(s) and the expense thereof. Jasminepetcare is released from all liability of injury to pet(s) caused by other pet(s) or animal(s) that's under the watch of Jasminepetcare as accidents can happen. Jasminepetcare is released from liability if the client's pet contracts kennel cough as that can happen if the pet participates in dog daycare.

ENTIRE AGREEMENT. This Waiver contains the entire agreement of the parties, and there are no other promises or conditions in any other agreement whether oral or written.

EXHIBIT C Veterinary Release Form
